Electric Golf Cart Charging and Battery Maintenance Charging

- Wear seat belts all times cart is in use. Local law enforcement will write you a ticket:
- **Carts should be plugged in at ALL times**, when not in use. Carts that are not plugged in can self-discharge and virtually “kill” the battery pack.
- Carts should always be charged overnight.
- Carts should be fully charged when returned to Coastal Soul Carts.
- Carts will be returned to Coastal Soul Carts (**No later than 10 a.m.** unless other arrangements have been made with management.
- Cart is only legally allowed to be operated in a 35 MPH and under zone.
- Do not plug your battery charger into an extension cord. The cord may overheat and may not be rated to handle the draw of the charger. We supply you with a soft 12 gage cord.
- Batteries should be charged after EACH period of use, no matter how short you used it. When plugging charger into cart, verify that the blue power light is on, and the green led light is flashing. This confirms that there is power to the cart and a working charger.
- Allow the charger to complete the charge process. **Both green lights will be solid. (Not Flashing)**
- Carts not properly charged resulting in a tow will be responsible for a \$100.00 tow fee.

COASTAL SOUL CARTS

Binding Golf Cart/LSV Rental Agreement

(Please Read carefully before signing and returning)

In consideration for the rental of the golf cart provided by Coastal Soul Carts, I _____ agree to following conditions. In the event that I violate any of the following conditions, I agree and understand that further use of the golf cart/LSV may be revoked immediately & without notice.

1. I promise to return the golf cart to the location provided immediately upon completion of the rental period in as good conditions as I received; the same, normal wear and tear is accepted. I will operate the golf cart/LSV safely and responsibly, and I will preserve and protect the golf cart from the loss or damage to the cart itself, my person or property, and the persons or property of others. I agree and understand failure to comply with the terms of this agreement will result in a forfeiture of my rental fees and deposit. I agree to be legally and financially liable for all costs of repairs to the golf cart and for the loss, damage and /or injuries to my person or property and the persons or property of others regardless of fault. I Agree to reimburse Coastal Soul Carts for such unrecovered costs, including but not limited to deductibles and any uninsured losses.
2. I agree to hold harmless, defend and indemnify Coastal Soul Carts and its affiliates for any and all damages and claims of any nature whatsoever that may arise from the use of said golf carts/LSV during the time of the rental period, including but not limited to claims for damages to the golf cart/LSV itself, my person and property and the persons and property of others.
3. I agree to become familiar with the operations and use of said golf cart/LSV, to read the "GOLF CART INFORMATION SHEET" and any other instructions provided to me regarding the cart, and to operate that cart in accordance with said instructions. I agree to contact Coastal Soul Carts if I have any questions or concerns about operating the golf cart or if my quest or I have caused any damage to the golf cart/ LSV or others through the use of the golf cart. I agree to examine and inspect the safety and mechanical condition of the golf cart/LSV, reporting any concerns or problems before driving the vehicle.
4. I understand that a golf cart/LSV is subject to the rules provided within this agreement and agree that the golf cart will be operated in accordance with the rules of Atlantic Beach and/or Town Ordinances, including but not limited to the requirement that persons driving the golf cart must not be under the influence of alcohol and/or illegal drugs. I understand that any violation of the rules, misuse or reckless operation of the golf cart/LSV will terminate the rental use of the vehicle and no refund of rental fees.
5. I agree that only persons who are 21 years or older can rent a golf cart/LSV, I must have a valid credit card on file, and I authorize any damages to the golf cart/LSV while in my rental period to be charged to said credit card. I may not allow any person that is under the age of 21 to operate the golf cart/LSV and all operators must have a valid drivers license. I am responsible for any liability/damages that may occur during my rental period regardless of

who is operating the cart/LSV. I am responsible for all drivers and passengers during the rental. I further agree that the maximum occupancy of the golf cart is 4 person unless this is a 6 passenger cart, including children, and also should have safety restraints on while operating.

6. I agree the privilege of using the golf cart/LSV can be revoked without notice by Coastal Soul Carts in their sole discretion, for any violation of this agreement. I further agree I shall not be entitled to a rental refund for such revocation of privilege.
7. Any keys not returned with the cart/LSV will incur an additional charge of \$10.00 per key. If lock/cable/key sets are provided with rental, customers will be charged \$40.00 per set if any part of the lock/cable/key set is missing (including key tags/fobs), or if the lock needs to be cut off.
8. Equipment is not permitted to be sub-leased by the renter to any individuals.
9. I understand that if the golf cart should become inoperable through no fault of mine, Coastal Soul Carts (252-659-0404) will take reasonable steps to have the golf cart repaired. In the event the golf cart can not be repaired/replaced, a refund will be issued towards the unused rental agreement period.
10. COASTAL SOUL CARTS IS NOT RESPONSIBLE FOR ANY ACCIDENTS involving said cart/LSV and is not responsible for any injuries that may occur with the person involved.

Golf Cart Operation Rules

Due to the special nature of these vehicles, please observe the following rules:

- NEVER operate the vehicle while impaired by alcohol, drugs, or medications.
- Pedestrians have the right of way.
- Be courteous at all times.
- The minimum age requirement to operate golf carts is 21 years old.
- Proper illumination must be displayed while operating at night.
- Modifying or disconnecting the speed control is prohibited.
- Apply parking brake and remove key while not in use!
- Recommended unattended carts be secured with properly locked cable and lock.
- Please obey traffic signage, directions and instructions by Atlantic Beach Safety Patrol
- Do not operate the cart/LSV outside the premises of Atlantic Beach/Emerald Isle
- Charging of the cart/LSV is not the responsibility of Coastal Soul Carts
- Obey golf cart seating capacity.
- Coastal Soul Carts is not responsible for lost or stolen carts/LSV

Please avoid the following

- Transporting passengers whose judgement may be impaired for any reason including but not limited to the consumption of alcohol.
- Transporting passengers not seated on the seat provided by the manufacturer.
- Passengers sitting in a backwards position on the front cowling or standing while in operation.
- Heavy loads that may shift while turning.
- When using reverse, please use extreme caution.
- Operating any vehicle without proper authorization at excessive speed, recklessly or without consideration to pedestrians
- No crossing of driving on the Atlantic Beach Bridge
- No entering speed zones greater than 35 MPH.
- If the cart/LSV needs to be towed in due to running out of battery, a tow fee of \$100 dollars will be charged.

REPORT ALL CRASHES/INCIDENTS INVOLVING THE VEHICLE TO COASTAL SOUL CARTS/OR LAW ENFORCEMENT OFFICIALS. FAILURE TO DO SO WILL RESULT IN THE SUSPENSION OF OPERATING PRIVILEGES. REPORT ALL CRASHED/INCIDENTS REQUIRING MEDICAL ATTENTION TO LAW ENFORCEMENT OFFICIALS IMMEDIATELY!!
